Scope of service:

Swallowologist is one of Speech-language pathology specialties who can clinically assess and manage patients with oro-pharyngeal dysphagia. Usually, patients who have oro-pharyngeal dysphagia complain of the following swallowing problems: 1) drooling; 2) coughing and/or choking on liquids or foods during or right after eating or drinking; 3) wet or gurgle voice during or after eating or drinking; 4) feeling of food sticking in the throat or upper chest; 5) extra time and effort required for eating; 6) history of recurring pneumonia or chest congestion after eating; and 7) weight loss or dehydration from not being able to eat enough. Oro-pharyngeal swallowing assessment is to approach patients with dysphagia that can be provided by a certified speech-language physician. A comprehensive dysphagia assessment by a speech-language physician help diagnose patients with different diseases such as respiratory disease, failure to thrive, unintended weight loss, chronic cough, etc., which interfere with swallowing ability.

The initial oro-pharyngeal swallowing assessment will include a careful review of the patient's history, clinical assessment of the strength, range of motion and coordination of the muscles involved in swallowing, and may entail observation of the patient eating and drinking. In addition, instrumental assessment of swallowing (videofluoroscopic swallow study and/or fiberoptic endoscopic evaluation of swallowing) are required to complete the oro-pharyngeal swallowing disorders management. The goals of the swallowing evaluation are to obtain a detailed analysis of the patient's oropharyngeal swallowing mechanism; to correlate these findings with the patient's dysphagia symptoms; and to assess effectiveness of therapeutic techniques, which might improve swallow function.

Swallowing therapy may include education in compensatory techniques to make swallowing more efficient and to reduce the risk of aspiration, diet modification, and/or instruction in exercises to strengthen and improve the coordination of the swallowing mechanism. Moreover, using VitalStim therapy might be helpful for some patients to strengthen muscles responsible for swallowing mechanism.

In addition, I'm certified as Health Informatician who provides the training and research opportunities for individuals to assess, develop, and implement new technologies that will provide decision support to health care professionals and biomedical scientists.

The explosion of medical and biological information has made it clear that innovative advances in storing, retrieving, and interpreting information are essential for health professionals and scientists. Physicians can no longer expect to master comprehensively the information in their areas of expertise. Instead, they must increasingly rely upon problem solving strategies and the ability to access systematically the information required for thoughtful patient care. For this reason, my job is by using system-analytic tools to coordinate or harmonize between the different medical technology and physicians who should be trained and involved in applying computer in their practice.
